RVSPCA Return Policy

The RVSPCA will accept all returned animals within 30 days of adoption. However, returns of animals must be coordinated in advance through the Behavior and Intake Coordinator. After 30 days, the return of an animal is subject to our normal intake process and cannot be guaranteed. RVSPCA does not provide a refund on returned animals except as noted in the refund policy below. The RVSPCA reserves the right to require owners who return an animal to the RVSPCA to participate in a 30 day waiting period before adoption another animal.

RVSPCA Refund Policy

The RVSPCA will provide a full refund if the animal is returned within twenty-one (30) calendar days of the adoption date if the animal has been diagnosed by a licensed veterinarian, with such diagnosis documented in writing and supplied to the RVSPCA, with a serious medical illness or condition (including, but not limited to parvo, distemper, panleukopenia).

I certify that the above information is true and correct to the best of my knowledge. I also acknowledge falsification of the above can result in me being denied adoption of an animal. The RVSPCA reserves the right to refuse any adoption.

I understand that completing the adoption application does not guarantee that I will be approved to adopt the animal.

RVSPCA Mask Requirements
